This has been an extremely busy month for our deputies. The summer has brought the usual influx of thousands of tourists and visitors from around the metro area, and from around the world. I've met people from England, France and China to name a few. We've all seen this huge influx of people at the parks and in the numbers of illegally parked cars along E. Columbia River Hwy along the Sandy River. With only 2-3 deputies in the gorge area, it's impossible to cite and/or tow every single illegally parked vehicle. Deputies issue cites when time permits and they tow offender vehicles when they present an obvious hazard.

Corbett has had a rash of burglaries this month. One house has been burglarized twice this past year and numerous firearms were stolen. I have received a lot of reports of about suspicious persons and vehicles. Some are isolated incidents and others seems to have a common theme. I have received a lot of reports about suspicious people going door-to-door to sell soap products or Kirby vacuum cleaning services. None of these people are positively identified so it's impossible to say who is legitimate. We all know that anyone can print an authentic -looking form of ID. I would use your best discretion when dealing with these people and to not feel pressured. I personally had one of these sales people put their foot in my door at my house when I tried to close the door. I know they can be very aggressive sales people even when they are legitimate.

Our other patrol district in the area of Barlow High School has also had a rash of burglaries. In one incident a homeowner came home and found 2 Hispanic males in his house. They fled at a high rate of speed, nearly hitting some nearby utility workers. They were in a black vehicle (possibly a Mercury or Chrysler) with chrome trim and tinted windows. The vehicle was in good condition and was about 10 years old.
