Local citizens and members of the Citizen Patrol were eager to "hit the streets" following a hit & run that occurred in front of the Corbett School. The suspect had just stolen a car in Gresham and then he hit an oncoming vehicle before fleeing on foot. 45-minutes after the crash, a citizen reported seeing the suspect on Gordon Creek Road, 3-miles from the crash scene. The young man was captured due to everyone's diligence and willingness to help. I don't think this young man will return to Corbett anytime soon! The top-left photo shows the deployed airbags and broken steering column in the stolen car. The 2nd photo was taken by a citizen as we began the track with a K9.



Destruction in the Gorge: A semi-truck burst into flames on I84 at Ainsworth after striking the concrete barrier. The driver escaped unharmed. The 2nd photo was taken by a homeowner on Brower Road after a black bear tried to get into his house. The homeowner reported that he shot the bear. Notice that the corner 2x4 stud is nearly shredded.
