Every summer the Sheriff's Office receives an influx of speeding vehicle complaints in the Corbett and gorge areas. If you have a speed complaint, please obtain a plate along w/ a description of the vehicle and driver if it's safe to do so. Immediately call the non-emergency#. It's possible that deputy could be in the area or positioned in a spot where he or she can wait for the offender(s) to pass by. Citizens have the right to sign a traffic complaint and must be willing to potentially testify in traffic court if the offender requests a trial.
