Deputies responded to a transient camp in a heavily wooded area along Larch Mt. Rd.. Unfortunately a large amount of garbage was left after the campers departed. MCSO Citizen Patrol volunteers spent about an hour cleaning up the trash for proper disposal.



The Citizen Patrol volunteers received a safety enhancement to their Ford Explorer. The county commissioner's office has agreed to pay for an amber light bar and strobes. The Sheriff's Office paid for the installation labor and extra reflective striping. This will greatly increase visibility for our volunteers when working along our roadways.
