The Corbett Community Resource Officer position is no longer on the county's budget cut list. The community support for this position was strong and garnered over 900 signatures on a petition. Deputy Graziano will resume oversight of the Citizen Patrol volunteer program. He hopes to continue in the assignment for four more years.

Several dump sites were found this past month in the Corbett area, with most of the sites on Larch Mt. Rd.. A suspect was identified in one case and the culprit returned with his truck to clean up the entire site. Generally, ODOT or County Roads crews are dispatched to the sites for clean up. In some cases, a deputy or the county Code Enforcement officer may assist with the clean ups. According to County Roads crews, this nuisance occurs county-wide and is not confined to Corbett.

Generally, if you see a vehicle loaded with junk, while heading easterly into the gorge or Larch Mt. Rd. area, you're asked to get a get plate and vehicle description and forward it to Deputy Graziano for follow-up. Otherwise, if the person(s) are actively dumping, then of course, please call 911.
