Deputies, Citizen Patrol volunteers and Search and Rescue volunteers recently went door-to-door to pass out landslide and flashflood information packets to 110 households east of the Bridal Veil area. This area is still very unstable and prone to hazards due to the fire damage.

This past month the Corbett area has had a small influx of homeless persons walking into the area. Some of the homeless are simply passing through and wish to be left alone. Deputies have received calls about others causing disruptions in the community. If you see someone that appears homeless and in need of assistance, it's best not to give them money. Instead, feel free to call the non-emergency number and a deputy can respond to assist; they have access to numerous resources. Some of the deputies are already familiar with the personal history of some members of the local homeless population and they can better-assist. In one particular incident, a young woman, acting very defiantly and walking in the middle of E. Columbia River Hwy. near the Job Corps, was taken into custody by order of her probation officer so that she could get much-needed mental health treatment. Her probation officer had previously been unable to find her. In another incident, a homeless man walked into the Corbett grade school and insisted that he was looking for a time capsule.
