

On 5/24/10 a tractor/trailer similar to the one shown, was heading south on E. Columbia River Highway. It turned right (west) to cross over the Stark Street Bridge. The passenger side of the trailer area struck the bridge and caused extensive damage. The damage is likely to have occurred in the mid-side area of the trailer. The trailer has exposed "ribs" on the exterior, a rounded belly and a shiny black color. It was likely a "side dump" trailer. It's possible that one of the ribs is bent. The front-top area of the trailer had a for-sale sign affixed. The white truck is similar to the one shown above.

The driver crossed the bridge and stopped briefly before fleeing the scene. The trailer may stand taller than the truck because the for-sale sign was visible from the front.

The driver is described as: a white male, mid 40s- early 50s. Approximately 5'6", 175 pounds. A gray "scraggly" beard. He wore sunglasses and an orange t-shirt.
