Locally, our deputies assisted the Columbia County Sheriff's Office in filling in on patrol districts after Ranier Police Chief Painter was killed. On the west side of town on Sauvie Island, our deputies have assisted in the investigation of the shooting of Lincoln City officer Dodds. The suspect lived on Sauvie Island.

Skye Dittmore, a local 14-year old Corbett student passed away this month due to health complications. A memorial was held at the Corbett School.
