There were only 2 reported vehicle break-ins this past month. Earlier in the month there were a series of 5 brush fires that were all reported at the same time along E. Columbia River Hwy. beginning just east of Smith Rd.. Luckily the fires were extinguished quickly with the aid of neighbors and passing motorists. Another arson occurred later in the month, however this was a stolen/recovered van in the gorge. It's not uncommon for suspects to ignite a "dumped" stolen vehicle. Stolen cars are also sometimes pushed down area boat ramps. These vehicle get recovered by the Sheriff's Office Dive Team. About 10 years ago, approximately 6 stolen cars were removed from the Cathedral Park boat ramp under the St. John's Bridge in one day. They had been piled on top of each other under the water.
